On behalf of NY CDG Genesee 5, LLC & NY CDG Genesee 6, LLC, LaBella Associates, D.P.C. respectfully submits these updated/additional materials for a proposed solar array to be located at 8244 Batavia-Stafford Townline Road in the Town of Stafford. This is in support of the application for site plan approval and a special use permit previously submitted to the Town in December 2023 and last reviewed by the Town on August 19, 2025.

A key improvement for the Genesee 5 and Genesee 6 Solar Projects, is the addition of an impervious gravel access road to replace the previously proposed Limited Use Pervious Gravel Access Road. This improvement was made due to the Town of Stafford Fire Department's stability concerns of the pervious gravel access road for emergency vehicle access. The large stone composition of the pervious gravel access road would not support the weight of the emergency vehicle requested. Therefore, we improved the access road to a standard impervious gravel access road and incorporated the necessary stormwater management facilities to capture and treat all runoff from the newly proposed impervious areas. The impervious road is also favorable to the USACE who is actively reviewing our proposed stream crossing on the Genesee 6 Solar Project.
